**DIRECTIONS TO ANIMAL URGENT CARE** – Go north from the building to 61<sup>st</sup> Street. Turn left onto 61<sup>st</sup> Street and go west to South Mingo Road. The clinic will be on the left side of 61<sup>st</sup> Street before you get to South Mingo Road.

**DIRECTIONS TO ANIMAL EMERGENCY CENTER** – Go north from the building to 61<sup>st</sup> Street. Turn left and enter Highway 169 on the right side of the street. Exit Highway 169 on 41<sup>st</sup> Street, turn right. Go west and clinic is about three (3) blocks west of Highway 169.

## NOTICE TO EXHIBITORS

**Training and Warm-up on the Grounds.** There will be no intensive or abusive training of the dogs on the grounds or premises at an AKC licensed or member obedience trial or sanctioned match. Collars must be in accordance with Chapter 2, Section 17 of these regulations. These requirements should not be interpreted as preventing handlers from moving normally about the grounds or premises or from warming up their dogs using any exercise performed in the obedience ring provided the dog is on a leash being held by the handler. Warm-ups should be performed as far from the obedience rings as is reasonably possible and must not be disruptive to any dog or person. Physical or verbal discipline of a dog will not be permitted, except to a reasonable extent in case of an attack on either a dog or a person.

All dogs will be kept on leash except when in the obedience ring, designated warm-up area, or exercise area. The superintendent, event secretary and Event Committee members shall be responsible for compliance with this section and shall investigate any reports of infractions.

- I. The safety of dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.
- II. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- III. All dogs must be on leash or crated at all times except when in the ring.
- IV. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made. No one shall have any claim or recourse against the Tulsa Dog Training Club, Inc. or any official thereof.
- V. Puppies under the age of 4 months are prohibited from the show grounds according to AKC regulations.
- VI. Exhibitors are responsible for being at the ring gate when it is their turn to run. Judges need not wait for any dog holding up a class. Tulsa Dog Training Club, the Trial Secretary, and stewards have no obligation or responsibility for providing service through a public-address system for the purposes of calling or locating dogs that are not brought into the ring when required. Conflicts will be handled on an individual basis before a class begins.
- VII. No smoking inside the building.
- VIII. Exhibitors must be governed by any rules or regulations of civil authorities, building, and parking restrictions. Vehicles parked contrary to regulations will be subject to towing at owner's expense.
- IX. The Tulsa Dog Training Club, Inc., and their agents, employees, etc. assume no responsibility for any loss, damage, or injuries sustained by exhibitors, handlers, their dogs, or property and further assume no responsibility for injury to children.
- X. Exhibitors are responsible for complete, accurate, and legible information on their entry forms; **illegible or incomplete entries cannot be entered in the show. IF THE ENTRY FORM IS PHOTOCOPIED, THE AGREEMENT ON THE BACK OF THE FORM MUST ALSO BE PHOTOCOPIED AND ATTACHED TO THE ENTRY WHEN IT IS MAILED. Unsigned Entry Forms cannot be accepted as well as entries which specify any conditions as to its acceptance.** Changes, Additions, or Corrections to entry forms MUST be received in writing prior to close of entries. Those received by telephone are NOT acceptable.
- XI. No refunds for duplicate entries. However, care will be taken to find duplicates before processing. No refund will be issued for any overpayment of \$10 or less. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in the event of such errors.
- XII. Checks that have been returned due to insufficient funds do not constitute a valid entry and will have a \$12.00 service charge attached. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY BASIS.
- XIII. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee, Veterinarian or Judge.
- XIV. No entry fee will be refunded if the trial cannot open or complete by reason of riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

## NOTICE TO EXHIBITORS

- XV. Bitches in season are not permitted in the trial. After closing, TDTC will refund 75% of the entry fees with a vet's certificate. This policy also applies to dogs injured after closing. The Trial Secretary must receive the written notification no later than 6:00 pm the day prior to the first day of trials. Refunds will be mailed within 10 working days. After closing, refunds will NOT be given for any other reason.
- XVI. The Tulsa Dog Training Club may decline any entries for cause and refuse to receive or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against TDTC or any official thereof.
- XVII. Any exhibitor arguing with show officials, exhibiting unsportsmanlike behavior violating AKC rules will be subject to Event Committee Jurisdiction.
- XVIII. If you use a wire crate, please bring a mat, blanket, or other suitable item to place under the crate to protect our floors.
- XIX. Due to space limitations, no x-pens or tents will be allowed.

### HOTEL ETIQUETTE

**Here are a few things you can do to increase privileges  
rather than restrictions on dog owners:**

- Tell the hotel ahead of time of arrival that you have a dog and how big it is. Make sure you let them know it is an obedience-trained dog.
- Tip the housekeeper the first night. Leave her a note thanking her for a nice room.
- Do not groom or bathe your dog in your room.
- Carry your own Simple Solution or such to clean up any accidents and do not use hotel towels. Travel with your own paper towels.
- If you must leave your dog in the hotel, leave him/her crated. Leave your cell phone number or a number where you can be reached with the front desk while you are out.
- Control barking. If your dog barks when you are gone, then do not leave him/her alone. Call out for your dinner instead.
- Take a sheet from home and put over bedspread if your dog will be on the bed.
- Do not let your dog urinate on the bushes and plantings. Go to a non-landscaped area, if possible, where it will not kill the plants.
- Pick up after your dog (and anyone else's) outside and deposit in an OUTSIDE TRASH RECEPTACLE.
- If your dog damages something, tell the management up front and pay for your dog's actions.

**It only takes ONE uncaring person to lock all of us out of a hotel. Show them that obedience people care about not only their dogs, but for others and their property as well.**
