Recent Class Changes Effective January 1, 2020 and July 1, 2024

Entering a Mixture of Regular and Preferred Classes Within the Same Trial Weekend – Multiple Jump Heights Within the Same Trial Day

Effective January 1, 2020, exhibitors may enter a mixture of both Regular and Preferred classes on the same trial day and/or during a trial weekend. Any mixture of Regular and Preferred classes is allowed. Please note that if a dog qualifies in Regular Master Standard and Preferred Master JWW (or vice versa) on the same trial day, then NO Double Q shall be earned toward either the MACH or PACH title. The Double Q still requires that Standard Agility and Jumpers with Weaves be either both Regular OR both Preferred on the same trial day.

Additionally, within the same Regular or Preferred classes, a dog may now be entered in multiple jump heights within the same trial day. For example, the same dog may now be entered in 20-inch Master STD/JWW while also entered in 24C-inch Premier STD/JWW on the same trial day.

A separate entry form must be submitted when the same dog is being entered in a mixture of Regular and Preferred and/or different jump heights within the same trial weekend thereby clearly indicating which class(es) and/or jump heights belong together for each trial day of the weekend.

Entering For Exhibition Only (FEO)

As of July 1, 2024, For Exhibition Only may be offered at the option of the host club. FEO will allow exhibitors to work with their dogs in a trial environment. FEO will be of value to new exhibitors or exhibitors that are having difficulty with a specific obstacle and/or ring environment. Participation in FEO is non-qualifying.

- FEO runs are treated as trial entries. The exhibitor must enter the class(es) prior to the
 closing date, pay class entry fee(s) and the Trial Secretary must record the entry in the
 Trial Catalog as part of the results for that class. FEO does not need to be noted on the
 entry form; the handler will declare the day of the show.
- Dogs may be entered in any jump height for FEO runs. If entered in an ineligible jump height, the team is committed to FEO for that run and must declare FEO on the start line. Day of show jump height changes are not allowed.
- Dogs may be entered in any level (Novice, Open, Excellent, Master). If the dog is not
 eligible for the level entered, the team is committed to FEO for that run and must
 declare FEO on the start line. Day of show level changes are not allowed.
- The exhibitor must declare FEO in the ring prior to leading out. FEO may be declared earlier (ex. when checking in at the gate board).
- Toys are allowed in the ring:
 - Toys must be non-audible.
 - Toys may not leave the handler's hand.
 - Toys that roll freely cannot be used.
- Food/treats are not allowed in the ring.
- FEO should be utilized for the benefit of the dog and not as a punitive correction. Harsh
 verbal and /or physical corrections shall not be tolerated. Any determination of
 harshness by the judge shall be immediately whistled and the handler will be dismissed
 from the ring.
- A judge must monitor the entire run. Judges can stop a run at any time.

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs fifteen (15) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number (Mixed Breed dogs that have been listed with AKC Canine Partners may participate provided their listing number has been recorded on the entry form) or approved Foundation Stock Service (FSS) breeds. Spayed bitches and neutered males are allowed to participate. Bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's functional movement will not be allowed to participate. No dog may compete if taped or bandaged in any way or has anything attached to it for medical purposes.

ENTRY INFORMATION

Entry fees are \$24.00 for the first entry of a dog in either class, (includes a \$3.50 AKC recording fee), and \$14.00 (includes a \$3.50 AKC recording fee) for any additional entry of the same dog per day. Entries close on November 21, 2025, at 6:00 P.M., after which time entries cannot be accepted, canceled, altered, or substituted, except as provided for in Chapter 11, Section 6 of Dog Show Rules. All entries must be submitted on official AKC Agility entry forms, one dog per entry form. A maximum of 10 dogs may be included in one envelope. Photocopies of front and back will be accepted only if legible and of official AKC size. Entries will NOT be accepted without fees, and back of entry form signed.

SHOW INFORMATION

OBSTACLES. RING CONDITIONS AND CRATING

The trial will be held indoors on two 90' x 95' packed dirt surfaces on rubberized equipment. Obstacles will meet the specifications in the current edition of the Regulations for Agility Trials. STALL CRATING IS AVAILABLE AT A COST OF \$20 PER STALL, IF PAID WITH YOUR ENTRY FEE. Stalls requested at setup will be \$30. Very limited crating is available outside of stalls. (Paid stickers will be available at setup and must be hung on stall doors during trial.) Stalls may be shared. Each stall has an electrical outlet.

RIBBONS

Ribbons will be awarded to the 1st through 4th place dogs in each jump height in each titling class. Qualifying ribbons will be awarded to all dogs receiving a qualifying score in each titling class. Dogs must qualify to receive placement ribbons. New title ribbons will be awarded to all dog/handler teams finishing a title. Double Q ribbons will be awarded to all dogs qualifying in both Master STD and Master JWW in the same trial. A Triple Q ribbon will be awarded for all dogs qualifying in Master STD, Master JWW and Master FAST in the **same trial**. Dogs earning a new MACH, PACH and/or PAX title will be awarded a bar and rosette.

MOVE-UPS

Pre-Trial move-ups will be accepted prior to 6:00 PM on December 1, 2025. Email Move-Ups to macadoo6@windstream.net. Faxes will not be accepted. Move-Up forms will be available at the Secretary's table for Saturday's and Sunday's trials.

CHECK IN AND WALK-THROUGHS

UNLOADING & LOADING

The Show Site will be available to exhibitors for setup on Thursday from 3 pm to 6 pm and beginning at 6:30 am on Friday, Saturday, and Sunday. <u>Please</u> no early set-ups unless you have volunteered to help with ring set and/or equipment moves via the Volunteer Sign-up sheet.

No parking in the alleyway between the buildings will be permitted. Fairgrounds may also limit parking in front of all doors.

BUILDING

Doors will be locked at 7pm, or the end of the trial, whichever occurs first and opened for exhibitors by 6:30 am the following morning. The building is not climate controlled. Concessions will be available.

CLEAN UP

NOTICE TO EXHIBITORS

- I. The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all the obstacles safely.
- II. Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- III. All dogs must be on leash or crated at all times except when in the ring or in the designated agility warm-up area.
- IV. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee, be asked to leave the trial site. In that case, no refund of any fees paid will be made. No one shall have any claim or recourse against the Tulsa Dog Training Club, Inc. or any official thereof.
- V. Puppies under the age of 4 months are prohibited from the show grounds according to AKC regulations.
- VI. Exhibitors are responsible for being at the ring gate when it is their turn to run. Judges need not wait for any dog holding up a class. Tulsa Dog Training Club, the Trial Secretary, and stewards have no obligation or responsibility for providing service through a public-address system for the purposes of calling or locating dogs that are not brought into the ring when required. Conflicts will be handled on an individual basis before a class begins.
- VII. No smoking inside the building. No dogs in the bathrooms or Concession area.
- VIII. Exhibitors must be governed by any rules or regulations of civil authorities, building, and parking restrictions. Vehicles parked contrary to regulations will be subject to towing at the owner's expense.
 - IX. The Tulsa Dog Training Club, Inc., and the Tulsa County Fair Board, their agents, employees, etc. assume no responsibility for any loss, damage, or injuries sustained by exhibitors, handlers, their dogs, or property and further assume no responsibility for injury to children.
 - X. Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries cannot be entered in the show. IF THE ENTRY FORM IS PHOTOCOPIED, THE AGREEMENT ON THE BACK OF THE FORM MUST ALSO BE PHOTOCOPIED AND ATTACHED TO THE ENTRY WHEN IT IS MAILED. Unsigned Entry Forms cannot be accepted as well as entries which specify any conditions as to its acceptance. Changes, Additions, or Corrections to entry forms MUST be received in writing prior to the closing of entries. Those received by telephone are NOT acceptable.
- XI. No refunds for duplicate entries. However, care will be taken to find duplicates before processing. No refund will be issued for any overpayment of \$10 or less. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in the event of such errors.
- XII. Checks that have been returned due to insufficient funds do not constitute a valid entry and will have a \$25.00 service charge attached. Subsequent returned checks from the same exhibitor may result in their being put on a CASH ONLY BASIS.
- XIII. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee, Veterinarian or Judge.
- XIV. No entry fee will be refunded if the trial cannot open or completed by reason of riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- XV. Bitches in season are not permitted in the trial. After closing, TDTC will refund 75% of the entry fees with a vet's certificate. This policy also applies to dogs injured after closing, The Trial Secretary must receive the written notification no later than 6 P.M. the day prior to the first day of trials. Refunds will be mailed within 10 working days. After closing, refunds will NOT be given for any other reason.
- XVI. The Tulsa Dog Training Club may decline any entries for cause and refuse to receive or may remove any dog on account of disease, viciousness, or other cause, and no one shall have any claim or recourse against TDTC or any official thereof.
- XVII. Any exhibitor arguing with show officials, exhibiting unsportsmanlike behavior violating AKC rules or not abiding by Covid requirements will be subject to Event Committee Jurisdiction.

All dogs that have not been officially measured for an **Agility Jump Height Card** may still compete; however, they must be measured by *a* Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or *back-to-back trials* only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Dogs enrolled in the **AKC Canine Partners Programs** may be eligible to enter all-breed AKC agility trials at the club's option. These dogs should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box.

Junior Handlers should enter their Junior Handler number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the front of this form, what is the relationship is the Junior Handler to the owner:
